We display and market your artwork as well as consider prints for all variety of products in the Print On Demand venue such as t-shirts, mugs, plaques, phone cases, etc. All of the inmate's portion of profits garnered from the sale of inmate's artwork is sent to their children or family, thereby alleviating any improprieties of inmates operating a business while incarcerated.

HOW IT WORKS

- Fill out this flyer with the necessary information (only required for the first submission).
- Send your artwork to Caged CONquest, 7809 Southtown Center #397, Bloomington, MN 55431.
- Every month you will receive an invoice of artwork received and sold and any monies sent to your recipient on record.
- Every month you'll receive a Caged Art newsletter highlighting artists as well as offering art themes and suggestions to inspire your artistic endeavors.

GUIDELINES

Send only original artwork.

Do not send trademarked works (i.e., Disney characters, Marvel/DC comic book superheroes, etc.)

You can set a minimum price for your artwork or let Caged Art price items based on trending markets.

TERMS

10% of all sales goes to charity victim fund

45% of sale goes to inmate's recipient on file

45% of sale goes toward Caged Art operating costs

TERMS AND CONDITIONS

Be sure to sign your artwork and include your name and number on the back of every piece.

If artwork has a title/name, place it in parentheses on back (i.e., "Ocean Sunset #3", etc.).

Artwork can be sent by an outside source to Caged CONquest on your behalf; be sure it includes the above information.

More than one piece of artwork may be sent at a time.

If you have a minimum price you'd like your artwork to be listed at, include it on a separate piece of paper along with description and/or name of artwork. You may also describe the medium (i.e., pen, pencil, acrylic, pastel, etc.).

All sizes of artwork accepted, from full canvas pieces to envelopes to small logo sized drawings and images.

All received artwork will be displayed online until sold or removed at the request of inmate by formal written request.

Artwork proceeds will be distributed as follows: 10% to victim fund, 45% to inmate recipient, 45% to Caged CONquest.

Unsold artwork can be requested by inmate to be sent to recipient on file or other address at the cost of \$10 per piece.

Caged CONquest may choose to make and sell prints or utilize artwork on Print On Demand products or any other mode of sales to generate profits (all proceeds dispersed the same as above).

Caged CONquest may display received artwork on any promotional materials, social media sites, and in any way to promote the business and sales of Caged Art and its artists.

Monthly invoices will be sent to inmates showing all artwork received and sold, as well as any funds sent to recipient.
